PROCEDURES AND ADVERTISEMENT DATES FOR THE ADVERTISEMENT OF LICENSES APPLICATIONS IN THE FREE STATE PROVINCIAL GAZETTE, ACCORDING TO THE FREE STATE GAMBLING AND LIQUOR ACT, 2010 (ACT NO. 6 OF 2010)

In terms of the Free State Gambling and Liquor Act, 2010 (Act No. 6 of 2010) and related regulations, all applications for licenses submitted to the Free State Gambling and Liquor Board must be accompanied, among others, with proof of publication in the Provincial Gazette and in at least one newspaper normally circulated in the area where the premises are situated.
