**PROCEDURES AND ADVERTISEMENT DATES FOR THE RENEWAL OF LICENSES IN THE FREE STATE PROVINCIAL GAZETTE, ACCORDING THE TO NEW FREE STATE GAMBLING AND LIQUOR ACT, 2010 (ACT NO. 6 OF 2010)**
