Acceptable bids will be evaluated by using a system that awards points on the basis of functionality, financial offer, and preferences, as set out in the bid document.

Bids scoring a minimum of 80 points out of 100 for functionality will be eligible for evaluation on price and preference.

Price and preference evaluation criteria will be as follows:

Bids are to be completed in accordance with the conditions and bid rules contained in the bid documents; one hard copy and one electronic copy (CD) of the proposals must be submitted and placed in the bid box indicated above before the closing time and date. All bids shall hold valid for 90 days as from the closing date.

The lowest or any bid will not necessarily be accepted and the MAPSEZ reserves the right not to consider any bid not suitably endorsed or comprehensively completed, as well as the right to accept a bid in whole or part. Bids completed in pencil will be regarded as invalid bids. Bids may only be submitted on the documentation provided by the MAPSEZ.
