Bids will be evaluated in terms of the new Preferential Procurement Regulation, 2017 Regulation 3(a)(ii) "if it is unclear which preference point system will be applicable, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system.

100 Points will be allocated for functionality. The assessment of functionality will be done separately from the 80/20 or 90/10 preference points system. It should be noted that bidders who fail to meet the minimum threshold of 70 points will not be considered for further evaluation.

The overall evaluation and adjudication of this bid will be in terms of the **Preferential Procurement Policy Framework Act No.5 of 2000** and the **Preferential Procurement Regulations, 2017** (80/20 or 90/10 Preferential Point System), whereby a value of 80/90 points will be allocated for the total competitive costs(price) of the bid and 20/10 points will be allocated for **B-BBEE Status Level of Contribution**. The formula is set out in Form SBD 6.1.

Failure on the part of a bidder to fill in and/or to sign this form and submit a B-BBEE Verification Certificate from a verification Agency accredited by the South African National Accreditation System (SANAS) or a Registered Auditor approved by the Independent Regulatory Board of Auditors (IRBA) or an Accounting Officer as contemplated in the Close Corporation Act (CCA) together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.
