Conduct a comprehensive Gambling and Liquor impact study in the Free State Province.

Background:

Free State Gambling and Liquor Authority (FSGLA) invites tenderers/ bidders to submit a proposal for the Gambling and Liquor impact study that will be conducted in the Free State Province. The study should be able to deal with issues that affect the industries, growth and development, transformation and effects of availability of alcohol, effects of Gambling including illegal gambling and the rolling out of additional modes of gambling. In light of the huge responsibility the Authority is facing to regulate the industry, it is significant that the Board come to be the source for accurate information and statistics relating to the industry in the province.

The terms of reference that details the requirements for the study and special conditions will be made available as part of the bid document. Interested tenderers/bidders can obtain detailed specifications and requirements from FSGLA offices as from Monday, 11th of July 2016 between 08h00 until 16h30 during Monday and Friday. Briefing session will be held on 22nd of July 2016, 10:00 at the below address.

This bid will be evaluated on a 90/10 preference point system in line with the Preferential Procurement Regulations, 2011 and the Preferential Procurement Policy Framework Act of 2000. In order to obtain the maximum of 10 points for B-BBEE, bidders should submit original and valid B-BBEE status level verification certificate or certified copies thereof together with their bids.

FSGLA reserves the right to withdraw this RFP at its own discretion. Proposals will be evaluated on Functionality, Price and B-BBEE in line with FSGLA's Supply Chain Management policies and guidelines. Short-listed proposals will be required to do presentations.

Closing date: all RFP responses should be submitted on or before the closing date **05th of August 2016** at 16:00.
No late proposals will be accepted.
