Provincial Treasury's Supply Chain Management Compliance Unit is amongst other things responsible for monitoring, oversight, support and capacity building in Supply Chain Management to all Provincial Departments and Public Entities.

It is also committed to assist Departments to improve good governance and implement sound practices which are aimed at enhancing and impacting positively on Audit outcomes, with vision 2014 clean Audit as the ultimate.

It is against this background that Free State Provincial Treasury (FPT) seeks to obtain the services of a suitable service provider to develop and implement a Supply Chain Management Toolkit/guideline which will support practitioners across the Province in all Provincial Departments and Public Entities to execute their daily tasks. It is therefore envisaged that once the toolkit is finalised/developed it will be automated, in order for practitioners to have access to it.

The second phase of project will be to formulate a training programme which is NQF Accredited and is linked directly to the toolkit.

1. OVERVIEW OF THE BID EVALUATION CRITERIA

The bid shall be evaluated in terms of the Preferential Procurement Policy Framework Act and its Regulations of which the 90/10 principle will apply (90 will constitute price and 10 BBBEE ratings).

Furthermore functionality will be applied separately wherein 18 points will serve as minimum score that must be scored for further evaluation.
