The formula is set out in form SBD 6.1. Tenders other than EMEs should submit **SANAS** Accredited Verification Agencies Certificate and Tenders who qualify as EMEs or QSEs should submit sworn affidavit signed by EMEs or QSEs representative and attested by a **Commissioner of Oath**. Failure to submit the aforementioned requirements would mean that tenders will forfeit B-BBEE Status Level of Contribution points.
