- Demonstrate ability to supervise construction of agriculture infrastructure material/equipment/facilities supply & installation;
- Understanding of procurement processes of agricultural inputs support in line with department Supply Chain Management (SCM) policies and regulations;
- Ability to transfer skills & development and capacity building to clients and officials; and
- Experience in working with government, agricultural organizations, commercial and emerging farmers.
