**Design, Develop a fully implemented Gambling and Liquor Database Management System (Web-based)**

Background:

Free State Gambling and Liquor Authority (FSGLA) invites tenderers to submit a proposal that will provide FSGLA with an integrated Enterprise Business System (EBS) as a single system that will assist its core business units with the administration functionalities and be able to perform their operational functions with easy collaboration of information within the FSGLA environment. The approved business process mapping document will be available to the approved bidder. The Reference document is available that details the requirements for such a system and the supply chain processes are included.

The EBS must manage validated FSGLA data uploads; store real-time data that must be accessible to all relevant users in the organisation at all levels (Head office, Regional offices). It must have built-in data validation, system security, disaster recovery and integrate with all other systems and information source for the Authority. The suitable service provider must have knowledge of software development with proven experience, capability and capacity to deliver complex projects on time and within budget.

Interested tenderers can obtain detailed specifications and requirements from FSGLA offices as from Monday, 13<sup>th</sup> January 2014. Briefing session will be held on 17<sup>th</sup> January 2014, 10:00 at the below address.
