Develop and implement Gambling and Liquor Database Management System (Web-based)

Background:

Free State Gambling and Liquor Authority (FSGLA) (herein referred to as "the Authority") invite tenderers/bidders to submit a proposal that will provide the FSGLA with an integrated Business IT Solution as a single system. This system must be able to assist the Entity's core business units with the administration functionalities. The approved business process mapping document will be available to the approved bidder. The Terms of Reference that details the requirements for such a system and special conditions will be made available as part of the bid document.

This bid will be evaluated on a 90/10 preference point system in line with the Preferential Procurement Regulations, 2011 and the Preferential Procurement Policy Framework Act of 2000. In order to obtain the maximum of 10 points for BBEE, bidders should submit original and valid BBEE status level verification certificates or certified copies thereof together with their bids.

However, this proposal includes functionality and therefore it will be evaluated on a set functionality criteria (detail functionality criteria will be outlined in the terms of reference document).
