ACT

To amend the Appropriation Act, 1996, and to appropriate an adjusted amount of money for the requirements of the Province in respect of the financial year ending 31 March 1997.

BE IT ENACTED by the Provincial Legislature of the Free State Province, as follows: -

Appropriation of adjusted amounts of money for requirements of the Province

2. Subject to the provisions of the Exchequer Act, 1994 (Act No 1 of 1994), there are hereby appropriated out of the Provincial Revenue Fund for the requirements of the Province, in respect of the financial year ending 31 March 1997, as a charge to the Provincial Revenue Account, the adjusted amounts of money shown in column 1 of the Schedule.
