# ACT

To appropriate adjusted amounts of money for the requirements of the Province in respect of the financial year ending 31 March 2003.

**BE IT ENACTED** by the Provincial Legislature of the Free State Province, as follows:-

*(English text assented to and signed by the Premier.)*

- Appropriation of adjusted amounts of money for requirements of the Province** 5
1. Subject to the provisions of the Public Finance Management Act, 1999 (Act No. 1 of 1999), there are hereby appropriated out of the Provincial Revenue Fund for the requirements of the Province in respect of the financial year ending 31 March 2003, as a charge to the Provincial Revenue Account, the adjusted amounts of money shown in column 1 of the Schedule. 10

2. This Act shall be called the 2002/2003 Adjustment Appropriation Act. 15
