WET

ACT

To repeal the Exchequer Act, as amended, and to provide for matters connected therewith.

BE IT ENACTED by the Provincial Legislature of the Free State Province, as follows:-

1. The acts mentioned in the Schedule are hereby repealed.

Savings

2. Anything done in terms of the provisions of the Exchequer Act, 1994, as amended, repealed in terms of section 1, shall be deemed to have been done under corresponding provisions of the Public Finance Management Act, 1999 (Act No. 1 of 1999), the regulations promulgated and the treasury instructions issued in terms of the Public Finance Management Act, 1999.
