ACT

To authorize certain unauthorized expenditure and to provide for matters connected therewith.

BE IT ENACTED by the Provincial Legislature of the Province, as follows:

Authorizing of expenditure	5
1. (1) The unauthorized amount of R601 401 307-00, set out in the Schedules which –	
(a) the Public Accounts Committee recommended for authorization by the Provincial Legislature; and	10
(b) is more fully described in the Report of the Auditor General on the Accounts of the Free State Provincial Government for the financial years 2001/2002, 2004/2005, 2005/2006, 2006/2007 and 2007/2008,	15
is hereby authorized in terms of section 34 of the Public Finance Management Act, 1999 (Act No. 1 of 1999) in the manner set out in subsection (2).	20
(2) The unauthorized amounts referred to –	
(a) in the second column of Schedule A, which represents unauthorized expenditure resulting from overspending of the Vote referred to in the first column of Schedule A, become a direct charge against the relevant Vote for the financial year indicated on the Schedule; and	25
(b) in the second column of Schedule B, which amounts represent unauthorized expenditure resulting from another reason than the overspending of the Vote, become direct charges against the Provincial Revenue Fund.	30
