ACT

To authorize certain expenditure and to provide for matters connected therewith.

BE IT ENACTED by the Provincial Legislature of the Free State Province, as follows:–

Authorizing of expenditure

1. The overexpenditure of R97 936 594.00 under programme 2 (Social Assistance Grants) in the Department of Social Development, which is more fully described on pages 96 and 120 of the Annual Report of the Auditor General for the financial year 2003/2004, which has been submitted to the Legislature, is hereby authorized to form a direct charge against the Provincial Revenue Fund.

The expenditure of R33 373 000.00 for the 2002/2003 financial year, which was incurred by the Department of Public Works, Roads and Transport, which is more fully described on page 98 of the Annual Report of the Auditor General, which has been submitted to the Legislature, is hereby authorized to form a direct charge against the Provincial Revenue Fund.
