ACT

To appropriate the additional allocation of an amount of money to the department of Local Government and Housing in respect of the financial year ending on 31 March 2009.

BE IT ENACTED by the Provincial Legislature of the Free State Province, as follows:-

Appropriation of the additional allocation of money for the requirements of the department of Local Government and Housing.

1. Subject to the provisions of the Public Finance Management Act, 1999 (Act No. 1 of 1999), there is hereby appropriated the additional allocation of money, in terms of section 26 and 36 of the Division of Revenue Act, 2008 (Act No. 2 of 2008), for the requirements of the Department of Local Government and Housing an amount of R68 000 000 (Sixty Eight million rand), in respect of the 2008/09 financial year, for the specific listed purpose, as set out in the Schedule. 10
