WET

Tot wysiging van die Wet op die Huis van Tradisionele Leiers, 1994, om die Lid van die Uitvoerende Raad vir Plaaslike Regering verantwoordelik te maak vir die administrasie van die Wet; om die verwysing na die Kommissie op Provinsiale Regering te skrap; en om voorsiening te maak vir aangeleenthede wat daarmee verband hou.

Wysiging van artikel 1 van Wet 6 van 1994

1. Artikel 1 van die Wet op die Huis van Tradisionele Leiers, 1994 (hierna "Wet 6 van 1994" genoem) word gewysig deur na die definisie van "lid" die volgende definisie in te voeg:

"LUR" beteken die Lid van die Uitvoerende Raad verantwoordelik vir Plaaslike Regering."

Vervanging van 'n woord in Wet 6 van 1994

2. Wet 6 van 1994 word gewysig deur die woord "Premier", waar dit ookal voorkom, met die uitdrukking "LUR" te vervang.

Wysiging van artikel 12 van Wet 6 van 1994, soos gewysig deur Wet 5 van 2000

3. Artikel 12 van Wet 6 van 1994 word gewysig deur subartikel (2) met die volgende subartikel te vervang:

"(2) Die voorsitter van die Huis stel, na oorleg met die [Kommissie op Provinsiale Regering en die Premier] LUR, 'n sekretaris en sodanige ander personeel aan as wat nodig is vir die afhandeling van die werk van die Huis."

4. Hierdie Wet heet die Wysigingswet op die Huis van Tradisionele Leiers, 2003.

ACT

To amend the House of Traditional Leaders Act, 1994, to make the Member of the Executive Council for Local Government responsible for the administration of this Act; to delete the reference to the Commission on Provincial Government; and to provide for matters incidental thereto.

BE IT ENACTED by the Provincial Legislature of the Free State Province, as follows:-

Amendment of section 1 of Act 6 of 1994

1. Section 1 of the House of Traditional Leaders Act, 1994 (hereinafter referred to as "Act 6 of 1994") is amended by the insertion after the definition of "House" of the following definition:

"MEC" means the Member of the Executive Council responsible for Local Government in the Province;"

Substitution of a word in Act 6 of 1994

2. Act 6 of 1994 is amended by the substitution for the word "Premier", wherever it occurs, of the expression "MEC".

Amendment of section 12 of Act 6 of 1994, as amended by Act 5 of 2000

3. Section 12 of Act 6 of 1994 is amended by the substitution for subsection (2) of the following subsection:

"(2) The chairperson of the House shall, after consultation with the [Commission on Provincial Government and the Premier] MEC, appoint a secretary and such other staff as may be necessary for the discharge of the work of the House."

Short title

4. This Act is called the House of Traditional Leaders Amendment Act, 2003.
