**Tot wysiging van die Wet op die Phakisa Korporasie vir Groot Sportbyeenkomste en Sportontwikkeling, 1997, ten einde voorsiening te maak dat die werksaamhede, bevoegdhede en verantwoordelikhede van die direksie tydelik in die verantwoordelike Lid kan vestig; en om voorsiening te maak vir sake wat daarmee in verband staan.**

**Wysiging van artikel 5 van Wet 4 van 1997**

1. Artikel 5 van die Wet op die Phakisa Korporasie vir Groot Sportbyeenkomste en Sportontwikkeling, 1997, word gewysig deur die volgende subartikel na subartikel (3) in te voeg:

“(3) In die afwesigheid van ‘n direksie, wat ingestel is ingevolge die bepalings van hierdie artikel, vestig die werksaamhede, bevoegdhede en verantwoordelikhede van die direksie, ondanks enigiets tot die teendeel vervat in hierdie Wet, vir ‘n maksimum tydperk van 4 maande, in die verantwoordelike Lid.”

2. Hierdie Wet heet die Wysigingswet op die Phakisa Korporasie vir Groot Sportbyeenkomste en Sportontwikkeling, 2003.

**ACT**

To amend the Phakisa Major Sport Events and Development Corporation Act, 1997, so as to make provision that the functions, powers and responsibilities of the board of directors may vest temporarily in the responsible Member; and to provide for matters incidental thereto.

**BE IT ENACTED** by the Provincial Legislature of the Free State Province, as follows:-

**Amendment of section 5 of Act 4 of 1997**

1. Section 5 of the Phakisa Major Sport Events and Development Corporation Act, 1997, is amended by the insertion of the following subsection after subsection (3):

“(3) In the absence of a board of directors, which is constituted in accordance with the provisions of this section, the functions, powers and responsibilities of the board of directors vest, notwithstanding anything to the contrary contained in this Act, for a maximum period of 4 months, in the responsible Member.”

**Short title**

2. This Act shall be called the Phakisa Major Sport Events and Development Corporation Amendment Act, 2003.
