It is hereby notified that the Premier has assented to the following Act which is hereby published for general information:-

No. 3 of 1995: Provincial Service Commission Amendment Act.

**GENERAL EXPLANATORY NOTE :**

**ACT**

To amend the Provincial Service Commission Act, 1994, so as to define a certain expression and to set out the functions of the Director General.

*(Afrikaans text signed by the Premier.)  
(Assented to 31 May 1995)*

**B**E IT ENACTED by the provincial legislature of the Orange Free State Province, as follows :-

**Amendment of section 1 of Act 3 of 1994**

1. Section 1 of the Provincial Service Commission Act, 1994 (hereinafter referred to as the principal Act), is hereby amended by the insertion after the definition of "department" of the following definition :

"Director General' means the officer contemplated in section 7(3)(a) of the Public Service Act who is appointed on the fixed establishment of the Provincial Administration;".

**Substitution of section 8 of Act 3 of 1994**

2. Section 8 of the principal Act is hereby substituted by the following section :

**"Departments, Director General, and heads of department**

8. (1) For the purposes of the administration of the Province there shall be the departments of the Provincial Administration mentioned in the first column of the Schedule.

(2) The Director General is the head of the Provincial Administration and shall be responsible for the efficient management and administration of the Provincial Administration, including the effective utilisation and training of staff, the maintenance of discipline, the promotion of sound labour relations and the proper use and care of State property.

(3) Each department shall have a head of department who as an officer shall be the incumbent of the post on the fixed establishment of the Province bearing the designation mentioned in the second column of the Schedule opposite the name of the relevant department, or the officer who is acting in that post : Provided that the Director General shall be deemed also to be the head of the Office of the Premier.

(4) A head of department shall perform the functions which he or she is by or under any law obliged or empowered to perform under the control of and in accordance with the directions of the Director General."

**Short title and commencement**

3. This Act shall be called the Provincial Service Commission Amendment Act, 1995, and shall be deemed to have come into operation on 18 August 1994.
