## ACT

To amend the Townships Ordinance, 1969, so as to extend the application thereof to the whole Province; to repeal certain other laws; and to provide for matters connected therewith.

**BE IT ENACTED** by the Provincial Legislature of the Free State Province, as follows:-

*(Assented to 10 June 1998.)*

**Substitution of section 44 of Ordinance 9 of 1969** 5

1. The following section is substituted for section 44 of the Townships Ordinance, 1969 (hereinafter referred to as the Ordinance):

**“Application of this Ordinance.** 10

**44. This Ordinance shall apply throughout the Province.”**

**Repeal of laws and savings** 15

2. (1) Subject to the provisions of subsections (2) and (3), the laws mentioned in the second column of the Schedule are hereby repealed to the extent indicated in the third column of the Schedule, as from a date determined by the Member of the Executive Council of the Province responsible for Local Government and Housing by notice in the *Provincial Gazette*. 20

(2) Different dates may so be determined by the said Member of the Executive Council in respect of different laws. 25

(3) Anything done under a provision of a law repealed by subsection (1) and which is capable of being done under a provision of the Ordinance, shall be deemed to have been done under such provision of the Ordinance.

**Short title** 30

3. This Act shall be called the Townships Ordinance Amendment Act, 1998.
