ACT

To amend the Free State Finance Management Act, 2003, by inserting section 7A; and to provide for matters connected therewith.

BE IT ENACTED by the Provincial Legislature of the Free State Province as follows:-

(English text assented to and signed by the Premier on 28 June 2016.)

Insertion of section 7A in Act 1 of 2003

1. Act No. 1 of 2003 is amended by the insertion of the following section after section 7 –

“Conditions for allocations

7A. (1) The MEC for Finance may, in writing –	10
(a) impose conditions on an allocation in an appropriation listed in the Schedule to an Appropriation Act as earmarked funds, to promote and enforce transparency and effective management of revenue, expenditure, assets, liabilities as well as practical implementation of allocations of departments or votes;	15
(b) stop the use of an allocation in respect of which conditions have been imposed in terms of paragraph (a), until such conditions are met;	20
(c) amend conditions contemplated in paragraph (a), which amendment may be retrospective, if –	25
(i) the amendment is in the interest of the relevant department or vote;	
(ii) the amendment does not negatively affect any vested rights; and	30
(iii) the amendment does not materially change the main purpose of the allocation.

Invoeging van artikel 7A in Wet 1 van 2003

1. Wet Nr. 1 van 2003 word gewysig deur die volgende artikel in te voeg na artikel 7:

'Voorwaardes van toewysings

7A. (1) Die LUR vir Finansies kan, skriftelik –

15

(a) voorwaardes oplê ten opsigte van 'n begrotingstoewysing wat aangedui word in die Bylae tot 'n Begrotingswet as toegewysde fondse, om openlikheid en effektiewe bestuur van inkomste, uitgawes, bates, laste asook die praktiese implementering van toewysings aan departemente of begrotingsposte te bevorder en toe te pas.

(b) die gebruik van 'n toewysing ten opsigte waarvan voorwaardes ingestel is ingvolge paragraaf (a) stop, totdat sodanige voorwaardes nagekom is;

(c) die voorwaardes bedoel in paragraaf (a) wysig, welke wysiging retrospektief kan mits -

30

(i) die wysiging in die belang van die betrokke departement of begrotingspos is;

(ii) die wysiging nie enige gevesigde regte nadelig beïnvloed nie; en

(iii) die wysiging nie weselik die hoofdoelwit van die toewysing verander nie.

(2) The stoppage of an allocation in terms of subsection (1)(b) and an amendment of conditions in terms of subsection (1)(c) must be disclosed in the Provincial Treasury's next quarterly report to the relevant Committee of the Provincial Legislature.

(3) “**earmarked funds**” wherever it is referred to in this Act or an Appropriation Act means funds allocated for a specific purpose by the Provincial Government.”.

2. This Act is called the Free State Finance Management Amendment Act, 2016 and commences on date of publication.
