AMENDMENT OF PERSONALISED NUMBER PLATE AND LICENCE NUMBER PLATE FOR THE FREE STATE

Under regulation 27, 28, regulation 28A and regulation 29(2) of the Road Traffic Regulations, 2000, issued in terms of the National Road Traffic Act, 1996 (Act No. 93 of 1996), I, TM Manyoni, Member of the Executive Council responsible for road traffic in the Province amend -

- a) Provincial Notice No. 52 of 2002 as amended by Provincial Notice No. 278 of 2006 relating to personalised number plate system; and
- b) Provincial Notice No. 51 of 2002 as amended by Provincial Notices No. 128 and 279 of 2006 relating to the licence number plate for the Free State,

as set out in the Schedule.

SCHEDULE

Amendment of regulation 1 of Provincial Notice No. 52 of 2002

1. Regulation 1 of Provincial Notice No. 52 of 2002 is amended by the deletion of the definition of "number plate validation label".

Amendment of regulation 16 of Provincial Notice No. 52 of 2002

2. Regulation 16 of Provincial Notice No. 52 of 2002 is amended by the substitution for said regulation of the following regulation:

"16. Display of a number [and the number plate validation label]

- (1) After licensing the motor vehicle, the user must [-
 - (a)] display the number on the motor vehicle concerned in the manner prescribed in the Regulations]; **and**
 - (b) **affix the number plate validation label as from 10 April 2002, inside the rear window on the lower left hand corner of the window, or if the motor vehicle does not have a rear window, or if the rear window is not transparent, the number plate validation label must be displayed in the manner prescribed in the Regulations for the display of a licence disc.**

- a) Provinsiale Kennisgewing No. 52 van 2002 soos gewysig deur Provinsiale Kennisgewing No. 278 van 2006 wat betrekking het op persoonlike nommerplaatstelsel; en

- (2) **A number plate validation label shall be valid for a period of two years from date of issue thereof].”.**
