**CONDITIONS OF ESTABLISHMENT AND OF TITLE**

The township HARRISMITH EXTENSION 31 situated on Portion 173 of Dorps Gronden van Harrismith No. 131, Administrative district Harrismith, Free State Province, consisting of 27 erven numbered 4924 to 4950 & Street numbered, 4923 as indicated on General Plan S.G. No. 1054/2011.

**A. CONDITIONS OF ESTABLISHMENT**

A.1 The Local Municipality has the right, if deemed necessary, to demand that the foundations for new buildings and extensions to existing buildings be designed by a professional engineer as prescribed by the National Building Regulations, and such engineer must pay due attention to the geotechnical report with reference to the soil conditions of the township, and which is available at the municipal offices in Maluti-A-Phofung.

A.2 No residential erf in this township shall be allowed direct access to road S1277 along the northern boundary of the township.

A.3 The township developer shall conclude a services agreement with the local municipality in which the responsibility, design, installation and maintenance of engineering services for the township is agreed.

A.4 Engineering Services: Access, Access Road and Storm Water Management.

(a) The township developer shall at his own cost and in terms of the services agreement with the local municipality, build an internal access road and access control gate from which the erven in the township shall gain access.

(b) All erven in the township must have access to the internal access road and the width of access to pan handle erven shall be no less than 4,0m.

(c) The township developer shall at his own cost and in terms of the services agreement with the local municipality, install an internal storm water drainage system for the township. This system will be adequate to accumulate, attenuate and discharge the township storm water into the municipal storm water system that services the area.

A.5 Engineering Services: Water Supply

(a) The township developer shall arrange with the local municipality and/or the bulk water services provider to supply portable water to the township.

(b) The township developer shall at his own cost and in terms of the services agreement with the local municipality, install an internal supply water network for the township.

Die dorp HARRISMITH UITBREIDING 31 geleë op Gedeelte 173 van Dorps Gronden van Harrismith No. 131, Administratiewe distrik Harrismith, Vrystaat Provinsie en bestaande uit 27 erwe genummer 4924 tot 4950 & Straat genummer 4923 soos aangedui op die Algemene Plan L.G. No. 1054/2011.

**A. STIGTINGSVOORWAARDES**

A.1 Die Plaaslike Munisipaliteit het die reg, indien noodsaaklik geag, om te vereis dat fondasies vir nuwe geboue en aanbouings aan bestaande geboue deur 'n professionele ingenieur ontwerp word soos voorgeskryf deur die Nasionale Bouregulasies, en sodanige ingenieur moet ag slaan op die geotegniese ingenieurs-verslag met betrekking tot die grond-toestande van die dorpsgebied, wat ter insae lê by die munisipale kantore te Maluti-A-Phofung.

A.2 Geen residensiële erf in hierdie dorp sal direkte toegang verkry tot pad S1277 aan die noordelike grens van die dorpsgebied nie.

A.3 Die dorpsontwikkelaar sal 'n diensteooreenkoms met die plaaslike munisipaliteit sluit waarin die verantwoordelikheid, ontwerp, installasie en onderhoud van ingenieursdienste vir die dorpsgebied ooreengekom word.

A.4 Ingenieursdienste: Toegang, Toegangspad en Stormwaterbestuur

(a) Die dorpsontwikkelaar sal op sy eie kostes en in terme van die diensteooreenkoms met die plaaslike munisipaliteit, 'n interne toegangspas en toegangsbeheerhek bou waardeur die erwe in die dorpsgebied toegang sal verkry.

(b) Alle erwe in die dorpsgebied moet toegang tot die interne toegangspad hê, en die wydte van toegange na pypsteel-erwe mag nie minder as 4,0m wees nie.

(c) die dorpsontwikkelaar sal op sy eie koste en in terme van die diensteooreenkoms met die plaaslike munisipaliteit, 'n interne stormwaterdreineringsstelsel vir die dorpsgebied installeer. Hierdie stelsel sal voldoende wees om stormwater te versamel, te atteneer en in die munisipale stelsel te stort wat die gebied bedien.

A.5 Ingenieursdienste: Watervoorsiening

(a) Die dorpsontwikkelaar sal alle reëlings tref met die plaaslike munisipaliteit en/of die diensverskaffer van grootmaat waterdienste vir die voorsiening van huishoudelike drinkwater na die dorpsgebied.

(b) Die dorpsontwikkelaar sal op sy eie koste en in terme van die diensteooreenkoms met die plaaslike munisipaliteit, 'n interne waterverspreidingsnetwerk vir die dorpsgebied installeer.

A.6 Ingenieursdienste: Riool

- (a) The township developer shall arrange with the local municipality and/or the bulk sanitation services provider for the connection of the internal sewerage system of the township to the municipal sewer network that services the area.
- (b) The township developer shall at his own cost and in terms of the services agreement with the local municipality, install an internal sewer network for the township.

**A.7 Engineering Services: Electricity**

- (a) The township developer shall arrange with the local municipality and/or the bulk electricity supplier for the connection of the township to the network that supplies electricity to the area.
- (b) The township developer shall at his own cost and in terms of the services agreement with the local municipality, install land internal electricity supply network for the township.

A.8 The township developer shall establish a legal entity being an association of future land owners (Home Owners' Association) and shall submit proof of the establishment of this legal entity, as well as the draft articles of association of this legal entity, the draft estate rules and building and architectural guidelines to the local municipality.

A.9 All internal access roads, communal land-uses and open spaces shall be transferred to the Home Owners' Association for the management and the maintenance thereof, simultaneously with the transfer of the first erven in this township.

A.10 All civil services to be installed by the township developer shall be transferred to the Local Municipality for the maintenance thereof, in accordance with the stipulations of the services agreement with the Local Municipality.

- (a) Die dorpsontwikkelaar sal alle reëlings tref met die plaaslike munisipaliteit en/of diensverskaffer van grootmaat sanitasiedienste vir die aansluiting van die interne rioleringsstelsel van die dorpsgebied by die munisipale netwerk wat die area bedien.
- (b) Die dorpsontwikkelaar sal op sy eie koste en in terme van die diensteooreenkoms met die plaaslike munisipaliteit, 'n interne rioolnetwerk vir die dorpsgebied installeer.

**A.7 Ingenieursdienste: Elektrisiteit**

- (a) Die dorpsontwikkelaar sal alle reëlings tref met die plaaslike munisipaliteit en/of diensverskaffer van grootmaat elektrisiteit vir die aansluiting van die dorpsgebied by die elektrisiteitsnetwerk wat die area bedien.
- (b) Die dorpsontwikkelaar sal op sy eie koste en in terme van die diensteooreenkoms met die plaaslike munisipaliteit, 'n interne elektrisiteitsnetwerk vir die dorpsgebied installeer.

A.8 Die dorpsontwikkelaar sal 'n regs persoon vestig welke 'n assosiasie van toekomstige grondeienaars (Huisseienaarsvereniging) is sal bewyse van die vestiging van sodanige regs persoon, sowel as die konsepktes- en statute van die regs persoon, die konsephuisreëls en bou- en argitektoniese riglyne indien by die plaaslike munisipaliteit.

A.9 Alle interne toegangspaaie, gemeenskaplike grondgebruike en oopruimtes sal aan die Huisseienaarsvereniging oorgedra word om dit te bestuur en te onderhou, gelyktydig met die oordrag van die eerste erwe in die dorpsgebied.

A.10 Alle siveledienste wat deur die dorpsontwikkelaar geïnstalleer word, sal na die Plaaslike Munisipaliteit oorgedra word om dit te onderhou, in ooreenstemming met die bepalings van die dienste-ooreenkoms met die Plaaslike Munisipaliteit.

**IN FAVOUR OF THE LOCAL MUNICIPALITY:**

- B.1 This erf is subject to the stipulations of the Town Planning Scheme of Harrismith.
- B.2 The owner of this property shall belong to the Home Owners' Association representing the property owners in this township, and shall pay such levies and abide by the rules laid down by the Home Owners' Association.
- B.3 All buildings plans must be approved by the Home Owners' Association prior to submission to the local municipality, and must be in accordance with the house rules and the building and architectural guidelines, as published by the Home Owners' Association from time to time.
