## PROVINCIAL NOTICE

## INVITATION FOR NOMINATIONS TO APPOINT PERSONS ON THE FREE STATE GAMBLING AND LIQUOR AUTHORITY

1. Section 6(1) of the Free State Gambling and Liquor Act, 2010 determines that the Free State Gambling and Liquor Authority shall *inter alia* consist of the following members:
  - (a) 1 member who is qualified to be admitted to practice as a legal practitioner in the Republic and has, for a cumulative period of at least 5 years after having so qualified, practised as a legal practitioner or performed service related to the application or administration of the law;
  - (b) 1 member who is an accountant or auditor in the Republic and has, for a cumulative period of at least 5 years after having so qualified, practised as such;
  - (c) not more than 9 members who must have proven business acumen or knowledge of the gambling or liquor industry, who are suitable for appointment to the Board.
2. Due to the fact that certain vacancies will shortly arise in respect of the abovementioned positions on the Free State Gambling and Liquor Board, as soon as the Free State Gambling and Liquor Act is promulgated and has taken effect, I, M.A. Dukwana, Member of the Executive Council responsible for Economic Development, acting in terms of section 8(1) read with section 14 of the Interpretation Act, 1957 (Act No. 33 of 1957) and the transitional provisions of the Act, hereby invite all interested persons to nominate candidates for appointment to the abovementioned positions on the said Board which nominations must be submitted not later than **25 June 2010**.

  - (a) clearly indicate for what category a person is nominated;
  - (b) be accompanied by a detailed *Curriculum Vitae* from which it could be determined that the nominee meets the requirements of the relevant category mentioned in paragraph 1 above; and
  - (c) be accompanied by a letter of acceptance of the nomination by the nominee.

## UITNODIGING VIR NOMINASIES OM PERSONE OP DIE VRYSTAATSE RAAD OP DOBBEL EN DRANKOWERHEID TE VUL

1. Artikel 6(1) van die Vrystaatse Wet op Dobbel en Drank, 2010, bepaal dat die Vrystaatse Dobbel en Drankowerheid *inter alia* uit die volgende lede bestaan:
  - (a) 1 lid wat gekwalifiseer is om toegelaat te word om as 'n regspraktisyn in die Republiek te praktiseer en wat vir 'n kumulatiewe tydperk van minstens 5 jaar nadat hy of sy aldus gekwalifiseer het, as 'n regspraktisyn gepraktiseer het of dienste verrig het in verband met die toepassing of administrasie van die regspleging;
  - (b) 1 lid wat 'n rekenmeester of ouditeur is in die Republiek en wat vir 'n kumulatiewe tydperk van minstens 5 jaar nadat hy of sy aldus gekwalifiseer het, as sodanig gepraktiseer het;
  - (c) hoogstens 9 lede wat bewese sakevernuif of kennis van die dobbel- of drankbedryf het, wat geskik is vir aanstelling op die Raad.
2.
