In terms of the Division of Revenue Act, Act No 2 of 2013 Section 29(2) for the 2013/2014 financial year and the Public Finance Management Act, 1999 Section 38(1) (l-n), the Provincial Treasury hereby publishes the information set out in Schedule 1 that relates to the allocation of the amounts as stated in Schedule 2 relating to the allocation of funds from the Provincial Revenue Fund by the Accounting Officer of the Department of Human Settlement to the Mangaung Metropolitan Municipality.

| 2. Purpose | To enable the Mangaung Metro Municipality to implement the bucket eradication projects as well as basic water reticulation for earmarked and prioritized erven in Bloemfontein, Botshabelo and Thaba Nchu. |
| 3. Measurable Outputs | Number of sites to be serviced: 3774 |
| 4. Conditions | <ul style="list-style-type: none"> • The funds for bucket eradication in prioritized areas in Bloemfontein, Botshabelo and Thaba Nchu to be utilized solely and strictly for this purpose. • The Mangaung Metro Municipality must make use of registered professional service providers within the boundaries of the Free State as a first priority (though the idea is noble, some of these matters are influenced by the capacity Grading levels required by the Project). • The Mangaung Metro Municipality must confirm in writing their own top-up funding for these projects • Once procurement of service providers has been finalized to promptly notify the Department thereof in writing and submit all copies of documents relating to the procurement of the service to be provided for in the agreement • Any interest earned on the funds by the Metro Municipality shall be utilized solely for all activities relating to bucket eradication in Bloemfontein, Botshabelo and Thaba Nchu and reported accordingly on monthly basis. • Mangaung Metro Municipality to make payment to appointed Service Providers within 30 days for work done. |

Allocation criteria | In terms of a negotiated Memorandum of Agreement concluded between the Department and the Mangaung Metro Municipality in October 2013, funds will be transferred by the Department of Human Settlements to the Mangaung Metro Municipality for the purpose of implementing the bucket eradication projects as well as basic water reticulation in Mangaung. |

Monitoring mechanism | <ul style="list-style-type: none"> • Monthly expenditure and reports on the movement of funds, including the capital and interest, in line with the PFMA and the annual Division of Revenue Act. • Annual financial statements relating to the transfer of funds and allocation thereof and the Auditor-General may audit the said financial statements. • Monthly non-financial performance progress reports. |
| 7. Projected Life | 2013 –2015 |
| 8. Payment Schedule | Payment with regard to financial support will be made according to the conditions of paragraph 4. |
| 9. Reason not incorporated in Equitable Share | According to Section 154(1) of the Constitution, the National Government and the Provincial Governments, by legislative and other measures, must support and strengthen the capacity of Municipalities to manage their own affairs, to exercise their powers and to perform their functions. |
