### **DESIGNATION OF CERTAIN AREAS AS TAXI RANKS: VARIOUS TOWNS AND CITIES IN THE PROVINCE**

In terms of regulation 2(1) of the Regulations Relating to Official Taxi Ranks in the Free State Province issued in terms of section 54(b)(vii) of the Free State Interim Passenger Transport Act, 1998 (Act No. 16 of 1998), I, TM Manyoni, Member of the Executive Council responsible for Police, Roads and Transport in the Free State Province, designate the following areas as the only official taxi rank for minibus taxi-type services in the areas of the Province that are set out in Schedule 1.

Designated areas of the Province that are set out in Schedule 2 constitute undesignated taxi ranks.
