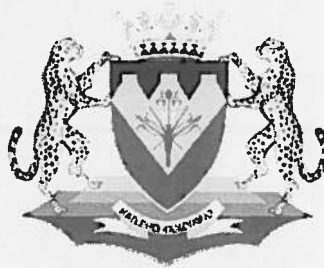

### AMENDMENT OF THE FREE STATE LIQUOR REGULATIONS, 2013 in re RENEWAL FEES

I, Mr MJ Zwane, Member of the Executive Council responsible for Economic Development, Tourism and Environmental Affairs in the Province, hereby give notice that I intend to amend the Free State Liquor Regulations, 2011, as set out in the Schedule.

In terms of section 133(4) of the Free State Gambling and Liquor Act, 2010 (Act No. 6 of 2010), all interested persons are invited to submit written comments to my office at the address set out hereunder, not later than 14 days from promulgation of this Notice:

### Amendment of Regulation 75

1. Regulation 75 of the Regulations is amended by the substitution for the following subregulation:

**“Fees payable annually in respect of a registration certificate**

75. Subject to Regulation 75C, there must, for the year following the year during which the Act comes into operation and for every calendar year thereafter, be deposited into the account of the Authority, in respect of each registration certificate (excluding a special events registration certificate), the annual fees set out in Part C of Schedule 3 and Part B of Schedule 6 on or before 31 December, annually: Provided that as a transitional measure, the annual fees in respect of Part B of Schedule 6 only applies to [2012/2013] 2013/2014.”

### Amendment of Regulation 75C

2. Subregulation (2) of Regulation 75C of the Regulations is amended by the substitution for the following sub regulation:

“(2) The annual renewal fees for [2012/2013] 2013/2014 must be paid in the prescribed manner before 28 February [2013] 2014.”

### Amendment of Schedule 6

3. Schedule 6 of the Regulations is amended by the substitution for Schedule 6 of the attached Schedule 6.

### Short title

4. These Regulations are called the Free State Liquor Amendment Regulations, 2013.
