PROCLAMATION

[No. 39 of 2011]

HUNTING SEASON: 2012

By virtue of the powers vested in me by section 4 of the Nature Conservation Ordinance, 1969 (Ordinance No. 8 of 1969), I, M.A. Dukwana, Member of the Executive Council responsible for Economic Development, Tourism and Environmental Affairs in the Province, hereby declare that any authorised person may hunt/capture ordinary game as follows:

Free State Province Hunting Season for the Year 2012	
Species of "ordinary game" in accordance with Schedule 2.	Period during which hunting or capturing of "ordinary game" may take place.
Helmeted Guineafowl (<i>Numida meleagris</i>), Swainson's Spurfowl (<i>Pternistes swainsonii</i>) Grey-winged Francolin (<i>Scleroptila africanus</i>), Orange River Francolin (<i>Scleroptila levaillantoides</i>), Common Quail (<i>Coturnix coturnix</i>). Egyptian Goose (<i>Alopochen aegyptiacus</i>), Spur-winged Goose (<i>Plectropterus gambensis</i>), Yellow-billed Duck (<i>Anas undulata</i>), Red-billed Teal (<i>Anas erythrorhyncha</i>). Red knobbed Coot (<i>Fulica cristata</i>).	1 st May 2012 up to and including 31 st August 2012. A maximum of ten (10) terrestrial gamebirds, and ten (10) waterfowl per hunter per day (including wounded birds and those not retrieved). Unlimited amount of birds per hunter per day.

Animals may be hunted on farms that have not been issued with an adequate fencing certificate in terms of section 2(2)(a) of the Game Theft Act, 1991 (Act No. 105 of 1991).
