ACCELERATED BUCKET ERADICATION PROGRAMME IN THE FREE STATE

1. Transferring Provincial Department	Department of Human Settlements
2. Purpose	To enable Bloem Water as an implementing agent to eradicate buckets in the Free State Province as part of the Rapid/Accelerated Eradication of Buckets Sanitation System.
3. Measurable Outputs	Eradicated 13 323 bucket sanitation system in those Municipalities with sanitation challenges in the Province.
4. Conditions	<ul style="list-style-type: none"> • The funds should only be used for the eradication of bucket systems in those Municipalities having sanitation challenges in the Province. • Bloem Water must make use of registered professional service providers within the boundaries of the Free State as a first priority if such providers are necessary to assist the Bloem Water to fulfil its function as an Implementing Agent. • Attend to all such legislative requirements and other arrangements to give effect to the provision of cash flow to appointed service providers to ensure the completion of the projects. • Bloem Water acknowledges receipt of the funds as per prescribed Limited Financial Assistance Return. • Bloem Water includes the amount in its Adjustment Budget. • Bloem Water reports back on the appropriation of the Limited Financial Assistance and submit supporting documentation in this regard. • Any interest earned on the funds by Bloem Water shall be utilized solely for all activities relating to eradication of bucket sanitation in the Province and reported accordingly on monthly basis.
5. Allocation criteria	In terms of a negotiated agreement entered between the Departments of Water Affairs, Human Settlements, COGTA and Bloem Water as the implementing agent for the Free State Water and Sanitation Programme with the aim of ensuring the Rapid/Accelerated Eradication of Buckets Sanitation System in the Province.
6. Monitoring mechanism	<ul style="list-style-type: none"> • Monthly expenditure reports as contemplated in section 12(3) of the 2013 DoRA and section 40(4)(c) of the Public Finance Management Act (PFMA), must be submitted by the 15th of every month for the preceding month. • Annual financial statements relating to the transfer of funds and allocation thereof and the Auditor-General must audit the said financial statements. • Submit monthly performance to the Department of Human Settlements by the 15th of every month for the preceding month.

	<ul style="list-style-type: none"> The monthly expenditure and performance reports must be signed by the Chief Executive Officer of Bloemwater
7. Projected Life	2013 /2014 to 2015/2016
8. Payment Schedule	Payment with regard to financial support will be made according to the conditions of paragraph 4.
9. Reason not incorporated in Equitable Share	The HSDG is a Schedule 5 Conditional Grant in terms of the DORA and can consequently not be incorporated in the Equitable Share.
10. Allocation	R230 000 000.00
