### FREE STATE PROVINCIAL TREASURY

#### DIVISION OF REVENUE ACT, 2018: ADJUSTED BUDGET ALLOCATIONS FOR DEPARTMENTS IN TERMS OF HOSPITALS, SCHOOLS, MUNICIPALITIES AND PUBLIC ENTITIES
