Notice is hereby given in terms of section 6 of the Roads Ordinance, 1968 (Ordinance 4 of 1968), as amended, that a Commission has been appointed for investigation in connection with an application for the closing of a section of public roads, as follows:

Description of routes:

**1. CLOSING OF A SECTION OF THE WELKOM – AASVOëLKOP SECONDARY ROAD S890, A-B-C, SITUATED IN THE MAGISTERIAL DISTRICT OF BLOEMFONTEIN (LENGTH ± 3,0 km):**

From point A on on the boundary line between Driefontein Noord 1873 and Kanon 1998; thence over Kanon 1998, Italie 1997, Boschrand 304, Surrey 695, Holvlakte "B" 2010 and Holvlakte "A" 2009, to point C on the boundary line between Holvlakte "A" 2009 and Gelukskop 2584.

**2. CLOSING OF A SECTION OF THE SURREY - PAARDEDAM TERTIARY ROAD T3314, B-D-E, SITUATED IN THE MAGISTERIAL DISTRICT OF BLOEMFONTEIN (LENGTH ± 3,5 km):**

From point B on Surrey 695, where it leaves secondary road S890; thence Surrey 695 and Subdivision 1 of Olive Hill 715, to point E on the boundary line between Subdivision 1 of Olive Hill 715 and Gelukskop 1162.

The proposals are indicated approximately on a plan in the offices of the Roads Superintendent, Mangaung, Bloemfontein and the Head: Police, Roads and Transport, Bloemfontein.

The investigation in connection with this application will commence in the office of the Roads Superintendent, Mangaung at 28 Hartley Street, Hamilton, Bloemfontein on Tuesday, 09 April 2019, at 10:00.

**2. SLUITING VAN 'N GEDEELTE VAN DIE SURREY - PAARDEDAM TERSIêRE PAD T3314, B-D-E, GELEë IN DIE LANDDROSDISTRIK BLOEMFONTEIN (LENGTE ± 3,5 km):**
