# ACT

To authorise certain unauthorised expenditure and to provide for matters connected therewith.

**BE IT ENACTED** by the Provincial Legislature of the Province, as follows:-

*(English text assented to and signed by the Premier on 30 March 2016.)*

## Authorising of expenditure

5

1. (1) The unauthorised amount of **R 39 334 548.06** set out in the Schedules which –

(a) the Provincial Public Accounts Committee recommended for authorisation by the Provincial Legislature;

(b) is more fully described in the Report of the Auditor General of South Africa on the Annual Financial Statements for the financial year 2014/15 and the Finance Act, 2015 (Act No. 2 of 2015),

is hereby authorised in terms of section 34 of Public Finance Management Act, 1999 (Act No. 1 of 1999) in the manner set out in subsection (2).

(2) The unauthorised amounts referred to –

(a) in the second column of Schedule A, become direct charges against the Provincial Revenue Fund in the 2015/16 financial year;

(b) in the second column of Schedule B, become a direct charge against the relevant Vote and it relates to **R28 142 263.11**, which was previously enacted by Finance Act, 2015, as a charge against Vote 10, Department of Police, Roads and Transport, for the financial years 2014/15 and 2015/16, but in terms of this Act aforesaid amount of Vote 10 is included in the amount to be charged against Vote 10 for the financial year 2016/17.
