[PROVINCIAL NOTICE NO. 79 OF 2017]**Department of Co-operative Governance and Traditional Affairs.****Correction Notice****Notice No. 34 is hereby withdrawn and is substituted by this Notice.**

Notice in terms of section 35 of the Local Government: Municipal Structures Act, 1998, read with section 139(4) of the Constitution of the Republic of South Africa, 1996 – Appointment of Administrator of the Metsimaholo Local Municipality and determination of powers and functions of the Administrator.

I, S.H. Ntombela, in my capacity as Member of the Free State Executive Council responsible for local government, subsequent to a decision of the Free State Executive Council on 29 June 2017, to dissolve the Metsimaholo Local Municipal Council in terms of section 139(4) of the Constitution of the Republic of South Africa, 1996, hereby –

- a) under powers vested in me by section 35(1) of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), appoint Mr Tekoetsile Moses Moremi as the Administrator of the Metsimaholo Local Municipality (“the Municipality”), with effect from 01 July 2017; and
- b) in accordance with the provisions of section 35(2) of the Local Government: Municipal Structures Act, 1998, determine that the Administrator must exercise and perform the following powers and functions:
 - i. assist with the approval of a temporary budget or revenue-raising measures to provide for the continued functioning of the municipality;
 - ii. undertake all executive functions of a municipal council except the legislative functions as outlined in section 160(2) of the Constitution, such as the approval of by-laws, the approval of the municipal budget and the imposition of rates, taxes, levies, duties, service fees and surcharges on fees;
 - iii. undertake all statutory executive functions of the Executive Mayor;
 - iv. undertake all fiscal and financial management functions at the municipality, including being signatory on the municipal primary banking account;
 - v. undertake all steps of section 54A and 56 of the Local Government: Municipal Systems Act, 2000 (Act No. 32 of 2000), including the removal of acting senior managers where applicable;
 - vi. undertake the functions referred to in section 67(1)(h) and Schedule 2 of the Local Government: Municipal Systems Act, 2000, read with any other relevant legislative provisions dealing with disciplinary matters, including criminal and civil actions;
 - vii. implement all governance systems and procedures including oversight over the Administration;
 - viii. ensure implementation of financial systems, policies and procedures;
 - ix. approve all decisions taken by the Municipal Manager or Acting Municipal Manager and section 56 Managers in terms of delegated or original authority;
 - x. revise the turn-around strategy for the Municipality;
 - xi. implement a system to control and approve all expenditure;
 - xii. ensure implementation of the Local Government: Municipal Property Rates Act, 2004 (Act No. 6 of 2004), including preparing the municipal valuation roll in terms of section 32(3) of the said Act where applicable;
 - xiii. set out a specific strategy for addressing the financial problems experienced by the Municipality, including a strategy for reducing unnecessary expenditure and increasing the collection of revenue;
 - xiv. review the organisational structure of the Municipality; and
 - xv. co-ordinate a programme of visits by all Provincial Government Departments at the Municipality in order to fast-track service delivery and prepare progress reports in this respect.

Additionally, the Administrator will exercise any powers and perform functions contemplated in terms of section 26 of the Municipal Finance Management Act, 2003 (Act No. 56 of 2003).
