The Electoral Commission hereby gives notice that it has in terms of section 11 of the Local Government: Municipal Electoral Act, 2000, compiled the election timetable set out below to apply to the municipal by-elections to be held on 23 August 2017 in respect of ward 03 of the Matjhabeng [FS184] Municipality as proclaimed by Provincial Notice number 91 of 2017 as published in the Provincial Gazette No 45 of the Free State Province dated 21 July 2017. A reference to "section" in this election timetable is a reference to that section in the Local Government: Municipal Electoral Act, 2000 (Act No. 27 of 2000).

Cut-off time for act to be performed

- 1 An act required in terms of this Act to be performed by not later than a date in the election timetable must be performed before 17:00 on that date, unless otherwise specified.

Certification of the voters' roll
