CORRECTION NOTICE: DIVISION OF REVENUE ACT, 2016: ALLOCATIONS TO MUNICIPALITIES IN TERMS OF LIMITED FINANCIAL SUPPORT

Provincial Notice No. 159 published in *Provincial Gazette* No. 49 of 27 July 2016, is hereby withdrawn and replaced with the notice set out below.

In terms of section 12(6)(a) of the Division of Revenue Act, 2016 (Act No. 3 of 2016), the Free State Department of Human Settlements hereby publishes the information set out in Schedule 1 that relates to the amounts as stated in Schedule 2. This allocation relates to planned expenditure from the Human Settlements Development Grant ("HSDG") with level 1 and 2 accreditation support for Mangaung Metropolitan Municipality.
