No. 967/2011 as approved by the Surveyor General on 9 November 2011 to be an approved township under the name Thabong, Extension 21, subject to the conditions as set out in the Schedule.

**CONDITIONS OF ESTABLISHMENT AND OF TITLE**

The township THABONG EXTENTION 21, situated on Portion 1 of the farm Adonai 773, Administrative district Ventersburg, consisting of 550 erven numbered 29553-29643, 29645-29803, 29805-30104, 2 parks numbered 29644 and 29804, 3 streets numbered 30105 to 30107 as indicated on General Plan S.G. No. 967/2011.

**A. CONDITIONS OF ESTABLISHMENT**

- A.1 Since this land is subject to unfavourable foundation conditions, foundations for new buildings and extentions to existing buildings should be designed by a Professional Civil Engineer as prescribed by the National Building Regulations and such Engineer must pay attention to the Geological Engineers Report with reference to the soil conditions of the township which report is available at the Municipal offices in Welkom.
