# ACT

To reduce the appropriation of the Department of Education in respect of the financial year ending on 31 March 2017.

**BE IT ENACTED** by the Provincial Legislature of the Free State Province, as follows:-

## Reduction of the appropriation of the Department of Education

1. Subject to the provisions of the Public Finance Management Act, 1999 (Act No. 1 of 1999) read with the Division of Revenue Act, 2016 (Act No. 3 of 2016), the appropriation of the Department of Education is reduced with an amount of R86.890 million as set out in the Schedule. The reason for the reduction is because the Infrastructure Grant of the said Department was stopped by the Department of Basic Education in terms of section 19 of the Division of Revenue Act, 2016.

## Short title

2. This Act shall be called the Second Special Adjustment Appropriation Act, 2017 and takes effect on 31 March 2017.
