SCHEDULE

A. Amend Clause A.2 by the insertion of the new definition for "Boutique Hotel", to read as follows:

"Boutique Hotel" means a small hotel with not more than 30 bedrooms, which have a unique character, appearance, architectural design and interior finishes. A boutique hotel may also include a Conference Centre for a maximum of 250 delegates, dining room and related health care/beauty parlour, entertainment/recreational area, restaurant and bar area."

B. Amend Annexure Two of the zoning "Special Business" by the insertion of the use "Boutique Hotel" as Type 16.

C. Amend Section G.1 – BUILDING LINE STIPULATIONS by the insertion of the stipulations for the use "Boutique Hotel" to the zonings "Special Business" and "Special Business (mixed)", to read as follows:
