In the event of it becoming necessary to pump water from elsewhere due to a drought condition the following steps need to be taken:			
RECOMMENDED PROCESS			
1. All consumers to be notified of water situation and watering of gardens restricted to 2 days per week for 2 hours only. 2. All consumers to be notified that the use of hose pipes is prohibited and if found using hose pipe a fine of R500.00 to be implemented and the hose pipe confiscated. (These measures to be implemented before the use of pumped water is necessary). 3. As soon as it becomes necessary to pump water from elsewhere, all consumers to be notified of the increase in tariffs. i.e. 0-6kl free > 7kl = R11.53 p/kl. 4. (2) and (3) to remain in force for as long as it is necessary to pump water from elsewhere.
