CONSULTATION PROCESS IN TERMS OF THE NATIONAL ENVIRONMENTAL MANAGEMENT: PROTECTED AREAS ACT, 2003 (ACT 57 OF 2003): INTENTION TO AMEND THE DECLARATION OF THE SEEKOEIVLEI NATURE RESERVE

Notice is hereby given by the Member of the Executive Council (MEC) for Economic and Small Business Development, Tourism and Environmental Affairs for the Free State Province, the Honourable Dr B Malakoane, in terms of section 33 (1)(a) of the National Environmental Management: Protected Areas Act (Act 57 of 2003 as amended) of the intention to amend the original declaration of the Seekoeivlei Nature Reserve (Declared in terms of Gazette Notice (Administrators Notice) 32 of the 10th February 1978) by declaring the properties reflected in the schedule herein under as additions to and as part of the **SEEKOEIVLEI NATURE RESERVE** (in terms of Section 23 (1)(a)(ii) of the aforementioned act);

The description of the portion of Seekoeivleipoort (1/1316), the portion of this farm to which this intention to declare applies specifically, is presented in Figure 2 hereunder.

Members of the public are hereby invited to submit written representation on, and/or objections to, the proposed amendment to the declaration of the Seekoeivlei Nature Reserve within 60 days of its publication in the *Provincial Gazette*. Written submissions must be lodged with;

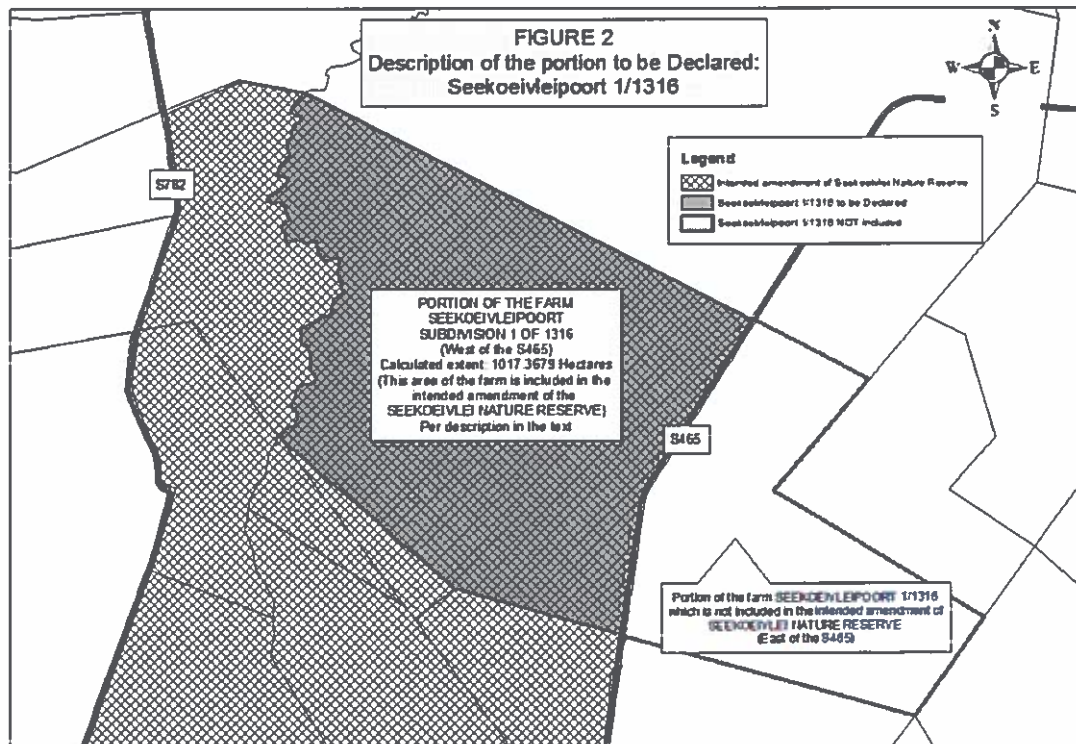
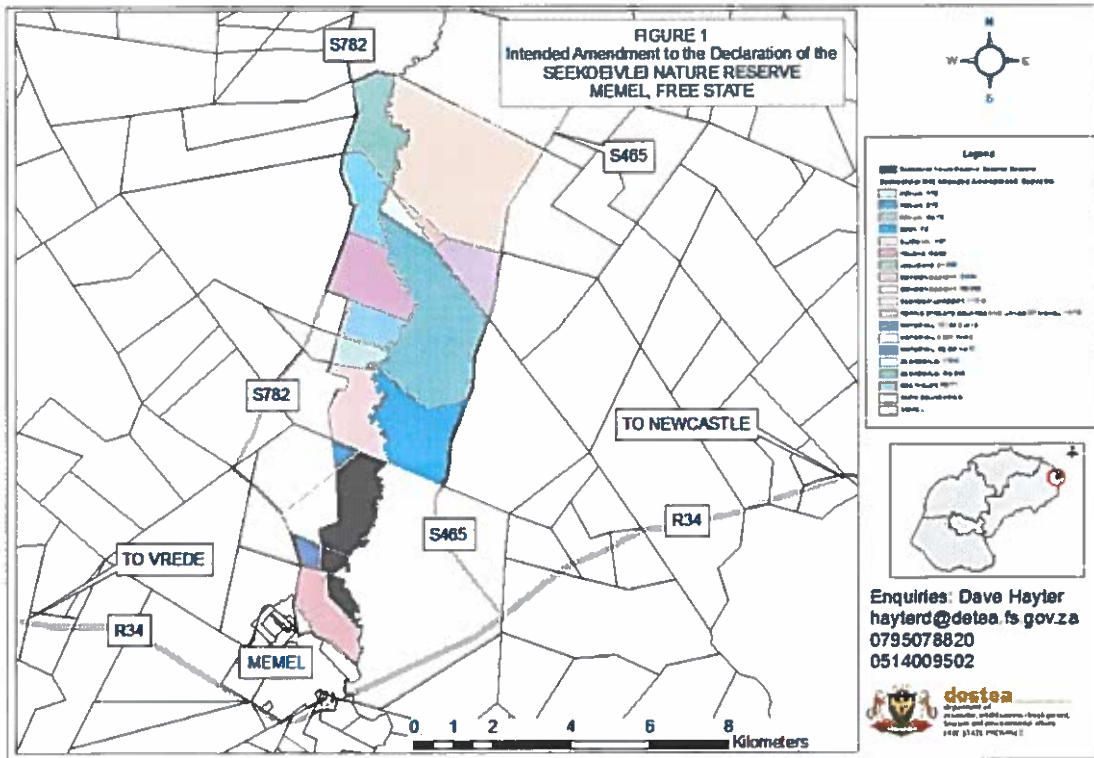
