NOTICE OF INTENTION TO APPLY IN TERMS OF SECTION 41 FOR THE TEMPORARY REMOVAL OF REGISTRATION

Notice is hereby given that the applicant mentioned in the Schedule hereunder intends to lodge an application for the temporary removal of registration on the first Friday of this month.

Any person may, within 21 days from date of publication of this notice, lodge in terms of section 33 of the Free State Gambling and Liquor Act, 2010, an objection in writing to the Free State Gambling and Liquor Authority (*addresses set out hereunder*).
