The proposals must include the following Mandatory Requirements:

- ❖ A valid Tax Clearance Certificate, or a unique security Personal Identification number (PIN) issued by the South African Revenue Services (where Consortium / Joint Venture / Sub-contractors are involved, each party to the association must submit a separate Valid Tax Clearance Certificate or a unique security personal Identification number).
- ❖ A valid proof of Registration on the National Treasury's Central Supplier Database (CSD) must accompany this bid.
- ❖ A Municipal services (water, sanitation, rates and electricity) clearance certificate or Lease Agreement with a Current Bill of Account not owing more than Ninety (90) days.
- ❖ A minimum of BBBEE level three (3) of contribution certificate or higher, i.e. Only BBBEE Certificate level of contribution 1, 2, 3 and 4 will be considered.
- ❖ A valid proof of registration with the relevant professional body/ies recognised by Council for Built Environment (CBE) – A separate proof must be attached for each discipline.
- ❖ A valid Attendance Certificate issued at the Compulsory Clarification Meeting must be attached to each Bid Document.

EVALUATION CRITERIA

Non-financial proposals are called for. The proposals will be evaluated on using two stage system with stage one focusing on mandatory requirements, and stage two focusing on responsiveness to the functionality criteria as outlined in the bid document. Bidders who fail to obtain a minimum of 70 points out of 100 points for functionality will not be considered further.

The Department of Public Works and Infrastructure commits itself to the advancement of Broad Based Black Economic Empowerment (B-BBEE) imperatives and thus, the successful bidders will be required to employ 60% black youth towards contributing to job creation.
