**ALL SUPPLIERS SEEKING REGISTRATION AS APPROVED SUPPLIERS**

From 1 September 2015 to 31 March 2016 (interim period) all prospective suppliers that wants to do business with the State will be able to first self-register on the Centralised Supplier Database (CSD) hosted by the National Treasury before registering on the Provincial Centralised Supplier database. All suppliers will be required to complete required information on the CSD website which can be accessed through [www.csd.gov.za](http://www.csd.gov.za) and must ensure it is complete, accurate and comprehensive

Once information has been verified with external data sources, a unique supplier number and security code will be allocated and communicated to suppliers. To register during the interim period on the Provincial Centralised Supplier Database, unique supplier number and security code must be provided to Provincial Treasury so that the details on CSD are used to register suppliers on the Provincial Centralised Supplier Database.

Provincial Supply Chain Management Compliance officials will be providing support to register (self-registration) on the CSD.
