- The internal audit must be conducted in accordance with the standards set by the IIA.
- The Internal audit function must, in consultation with the Audit committee, Prepare:
 - A risk register based on its assessment of the key areas of risk for the public entity, taking into account its current operations, the operations proposed in its corporate or strategic plan and its risk management strategy;
 - A rolling three year strategic and annual internal Audit Plan
 - Plans indicating the scope, cost and time lines of each audit in the annual risk based internal audit plan;
 - Audit reports directed to the Audit Committee detailing its performance against the plan to allow for effective monitoring and intervention where necessary;
 - The internal audit function must co-ordinate with other internal and external providers of assurance to ensure proper coverage and to minimize duplication of effort;
 - Transfer of skills to incumbent staff member who will be appointed for Internal Audit Services

The activities of the service provider include but is not limited to:

- Administration
- Risk based Internal Audits
- Fraud and Ethics Management
