The overall evaluation and adjudication of this bid will be in terms of **the Preferential Procurement Policy Framework Act No.5 of 2000**, **Preferential Procurement Regulations, 2017** (80/20 Preferential Point System), whereby a value of 80 points will be allocated for the total competitive costs(price) of the bid and 20 points will be allocated for **B-BBEE Status Level of Contribution**. The formula is set out in Form SBD 6.1.

Failure on the part of a bidder to fill in and/or to sign this form and submit a B-BBEE Verification Certificate from a verification Agency accredited by the South African Accreditation System (SANAS) or sworn affidavit signed by the EME representative and attested by a Commissioner of oaths together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.
