  - Only SANAS Accredited BBEE Verification Certificate or in case of EME/QSE a sworn affidavit downloaded from DTI website and signed by a commissioner of oaths will be accepted.
  - 80/20 preferential system will be applicable to the bid.
  - Bid documents must be completed as required.
  - All conditions set out in the bid document must be adhered to.
