GENERAL ASSESSMENT RATES AND TARIFFS: 2019/2020 FINANCIAL YEAR**

1. Notice is hereby given in terms of section 17(3)(a)(ii) and 24(1)(2) of the Municipal Finance Management Act 2003 and section 14(1) and (2) of the Local Government: Municipal Property Rates Act 2004 that the Municipal Estimates of Revenue and Expenditure for the 2019/2020 financial year has been approved by Council on 29 May 2019, of which a copy is available for inspection at the Office of the Chief Financial Officer during office hours.
2. Notice is also hereby given that:
  - I. The general assessment rates for the financial year ending 30 June 2020 has been assessed in accordance with the provisions of section 24(2)(c) of the Act:

Industries	0.044529	0.0436130
Businesses	0.017799	0.0174327
Residential	0.00889	0.0087071
Agricultural	0.0022296	0.0021838

3. The aforementioned rates are recoverable by the Council in terms of the provisions of the Act and payable in equal monthly instalments except for agricultural land and state property. In terms of section 24(2)(c) of the Act and section 64(2) of the Municipal Finance Management Act 2003, interest is payable on all rates in arrears
4. **Tariff decrease:**
  - Assessment Rates = 2% (all categories)
5. **Tariff increase:**
  - Water Tariffs = Between 0 % to 12.2%
  - Waste Management = 5.6%
  - Waste Water Management = 5.6%
  - Electricity = 9.4% – 13.07% (guideline from NERSA)
  - Other Tariffs = Average 5.6%
