1. Transferring Provincial Department	Department of Human Settlements
2. Purpose	To assist Maluti-a-Phofung Local Municipality to complete the land development application on portion 103 and 144 of Harrismith Dorpsgronden 131 for implementation of the upgrading of the informal settlements programme.
3. Measurable Outputs	Number of erven developed in line with the approved Surveyor General Diagram including the opening and proclamation of township.
4. Conditions	<ul style="list-style-type: none"> • The funds for Township Establishment of 1500 erven/sites at Linda Mkhonto in Harrismith, Maluti – a – Phofung Local Municipality to be utilized solely and strictly for this purpose. • The Maluti-a-Phofung Local Municipality must provide the FSHS with monthly progress reports on the project in line with the proposed business and project implementation plan with specific milestones; compiled by the Municipality and submitted to the FSHS • The Maluti-a-Phofung Local Municipality must ensure within their legislative requirements and other arrangements to give effect to the approval of the township • The Maluti-a-Phofung Local Municipality must complete the project to the stage of a township register and furnish the FSHS with proof of Surveyor General (SG) approval as well as proof of Township register. • The money will be paid to the Maluti-a-Phofung Local Municipality in tranches upon completion of each of the set milestones as indicated below: <ul style="list-style-type: none"> i. <i>Social Compact: R302 107</i> ii. <i>Completion of Special Studies: R755 267</i> iii. <i>Municipal Planning Tribunal Approval: R302 107</i> iv. <i>Submission of Surveyor General: R453 160</i> v. <i>Surveyor General Approval: R604 214</i> vi. <i>Township Register R604 214</i>
5. Allocation criteria	<p>Allocation is based on the financial position of the Municipality.</p> <p>Both the Free State Department of Human Settlements and Maluti-a-Phofung Local Municipality have signed the Memorandum of Understanding in June 2021 that allows the Municipality to continue with the service provider they have appointed to complete the township establishment application in Linda Mkhonto Informal Settlements in line with the amount allocated to the project in the approved Upgrading of Informal Settlements Partnership Grant Business Plan for 2021/22. This agreement allows for the Free State Department of Human Settlements to transfer money in tranches to Maluti-a-Phofung Local Municipality in line with the agreed project milestones</p>
6. Monitoring mechanism	<ul style="list-style-type: none"> • Submission of invoices from the Service Provider on work done, completed and verified, supported by portfolio of evidence as well as downloaded Data file which will reflect all payments and credits per month according to the correct expenditure classification. • Expenditure reports on the movement of transferred funds, Annual Financial Statements relating to the transfer of funds and allocation thereof which will allow the Auditor-General to audit the said financial statements. • Monthly non-financial performance progress reports.
7. Projected Life	The payment of R3 021 070 will be paid in tranches of milestones completed during the 2021/22 – 2022/23. The appropriation of which must be reported back on or

	within 30 days from date of receipt.
8. Payment Schedule	Payment with regard to financial support will be made according to the conditions of paragraph 4.
9. Reason not incorporated in Equitable Share	<p>According to section 154(1) of the Constitution, the National Government and the Provincial Governments, by legislative and other measures, must support and strengthen the capacity of Municipalities to manage their own affairs, to exercise their powers and to perform their functions.</p> <p>Through the Upgrading of Informal Settlements Partnership Grant, Provinces and Metros are mandated to support projects within the Municipalities in line with the approved business plans for each financial year.</p>
